Trademarks Use Arrangement

As a customer/potential customer/dealer of genuine Mul-T-Lock® products (“**Products**”), you are aware that we encourage extensive and proper use of our trademarks.

We hereby grant you limited-term, non-exclusive permission to use the **Mul-T-Lock® / Interactive® / MT5®** trademarks and the **Muscleman Logo** trademark, exactly in accordance with our Brand Management Manual (“**BMM**”) or as they appear in the letterhead of the original copy of this document (the “**Trademarks**”), only in connection with the resale of the Products in [redacted] (the “**Territory**”). This permission covers legitimately advertising and promoting Products in the Territory only in a manner acceptable to us and in accordance with the BMM according to the version in force at any given time, and any written directions which we may give to you from time to time.

You acknowledge that the Trademarks are the exclusive property of Mul-T-Lock Ltd or Mul-T-Lock Technologies Ltd and/or its affiliates (collectively “**Mul-T-Lock**”) in relation to the Products. You will ensure that the Trademarks are always used with an ®, to indicate their worldwide registration, and that all the Products that you sell and all promotional material that you use for the Products bear only the Trademarks, and no other trademark, unless you have been otherwise authorized in writing by us. You will not obscure or modify the Trademarks in any way, and not apply the Trademarks to any goods not manufactured or distributed by Mul-T-Lock.

You may use any advertising or promotional materials obtained from us containing the Trademarks to promote the Products in the Territory. Nevertheless, you will submit to us for our prior written approval any proposed new use of the Trademarks, including but not limited to any new advertising and promotional material containing the Trademarks, prior to your using such material and/or making such use of the Trademarks.

You will not do anything that may in any way jeopardize the Trademarks, or their ownership, and you will not make any use of the Trademarks other than as expressly permitted by this Arrangement. You will not use or register any trademark or trade name identical or similar to the Trademarks, or to any other name that Mul-T-Lock may use to identify itself and/or its products, and you will not register a company and/or establish or run any business entity, domain name, URL, website and/or e-mail address with any similar or identical names.

You will provide immediate, written notice of any misuse of the Trademarks to the responsible Mul-T-Lock marketing manager.

The permission to use Trademarks under this Arrangement shall terminate once you cease acquiring Products directly from Mul-T-Lock or from any entity approved in advance and in writing by Mul-T-Lock, or upon receipt of written notice by Mul-T-Lock withdrawing this permission, whichever is earliest. Upon termination of this permission, you will immediately cease and abandon further use of the Trademarks.
